We are committed to safeguard the privacy of individuals with respect to your personal data. 01. Updates

03. Use of personal data collected

We may use and retain the personal data provided by you for the following purposes and for other purposes as shall be agreed between you and us or required by law from time to time:

- 2.1 To provide, manage, administer and develop different features of the App.
- 2.2 To communicate with you, such as to respond to your requests.
- 2.3 To maintain the security of data and our services.
- 2.4 To understand how users use our App features and functionality to improve user experience and provide you with information about us and our range of Services.
- 2.5 To manage our business, such as operating and maintaining the quality of our operations and services.
- 2.6 To comply with laws, regulations or any requirements of any government agency or agency or regulatory body.

04. Your rights

- 6.4 We keep your personal data where this is advisable to safeguard or improve our legal position (for instance in relation to statutes of limitations,

security, litigation, or regulatory investigations).
